Chairmen's Message

On behalf of the volunteer Board and Committee members and the staff of the Kitsap Community Foundation, we are pleased to report that the affairs of the Foundation remain in good order. Please accept this Annual Report for our 2006/2007 fiscal year as evidence of our activities:

Our year began with the exciting prospect that the former Heronswood Nursery property in Kingston might be preserved when the Friends of Pacific Northwest Horticultural Conservancy Fund was established at the Foundation. Its purpose is to support acquisition and preservation of the internationally-renowned botanical garden and plant collection. The creators of the Fund have established a goal of creating a community-based, self-sustaining horticultural research and education center, which would collaborate with local higher education institutions.

Closely following, the Foundation was notified that it had met the nation's highest philanthropic standards for operational quality, integrity, and accountability. The certification was given by the Council on Foundations, a national professional association based in Washington, DC: "This is similar to the Good Housekeeping Seal of Approval for community foundations," said Steve Gunderson, Council President and CEO, upon announcing our recognition. The demanding process we followed in applying for this certification served as a wonderful opportunity for us to confirm our activities and services to the Kitsap community while providing us with some 'best practices' from our foundation peers through-out the country.

In keeping with our purpose, the Foundation issued nearly \$75,000 in grants and scholarships during the year. A listing of each is found within this report.

Additionally, we were pleased to recognize individuals and organizations who give back to our community: At our 2007 Celebration of Philanthropy, the patrons of the Kitsap Community Foundation honored Elizabeth and Don Drury, Tex Lewis, and Martha & Mary for their tireless contributions to the improvement of the quality of life for all our neighbors.



As alluded to earlier, our Mission is to **Improve the Quality of Life in Kitsap County Through Endowment-Funded Grants**: Endowments are the ‘forever funds’ that will ensure an ongoing grant-making stream to support and encourage the broader community good. To do so, we offer a variety of funding options to match our donor/investors’ desires to give back to their community in a meaningful, directed way of leaving a permanent legacy for future generations.

Our four guiding objectives establish our focus:

1. *Building Endowments* – We currently manage fifty-one Funds designated for the benefit of future generations.
2. *Making Grants* – Distributed thirty-three grants, awards, and scholarships.
3. *Establishing Credibility and Increasing Visibility* – Increasing your knowledge about the charitable services offered by the Foundation.
4. *Prudent and Effective Management* – Because we promise to be here forever, we plan for measured growth – balancing risk with return on investment – as we manage nearly \$1.75 million in assets.

As you review this brief snapshot, we would like to thank you for your passion for our community, your support of Kitsap Community Foundation, and your investment in our mutual future.
